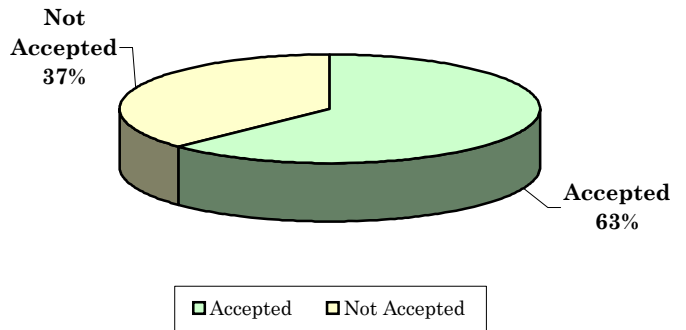

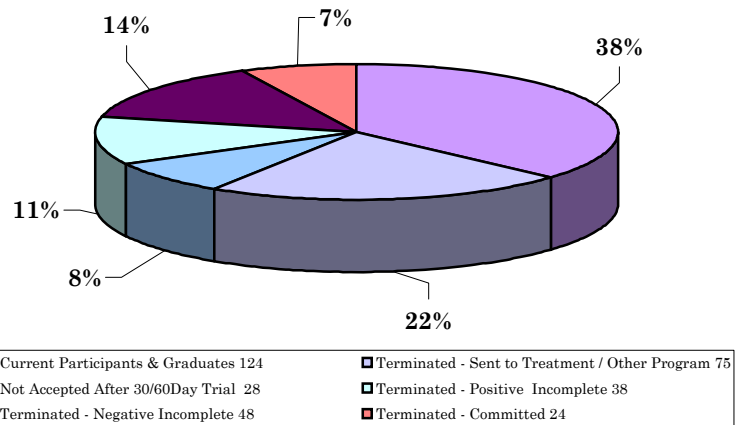

Retention Rate

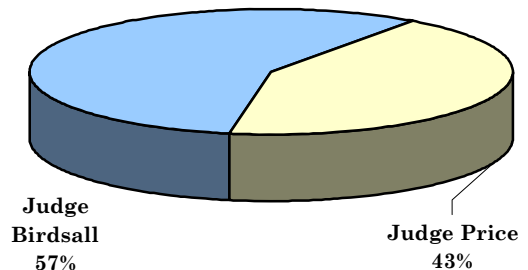

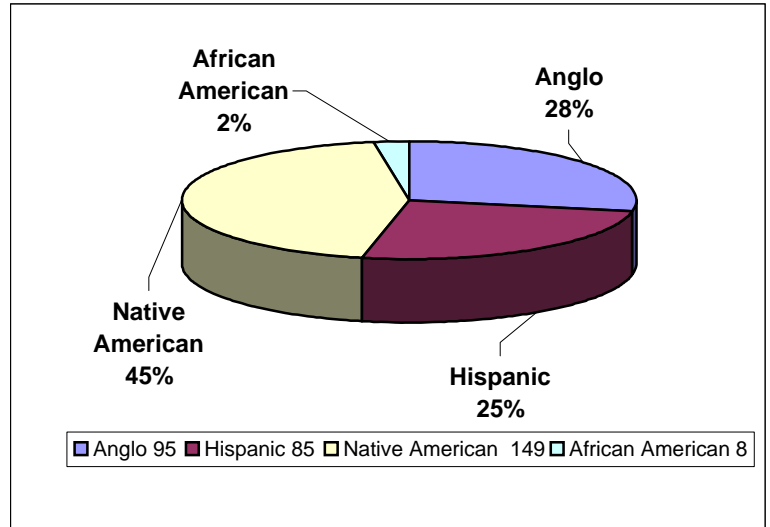
